1 Summary of Performance

1.A Introduction

This Budget Performance Report for Borno State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes, the original approved budget and appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2022 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Planning and Budget/ Borno State equivalent and published on the Borno State website.

1.B Revenue Performance

Aids & Grants and Capital Receipts performance is low in 1st quarter 2022, notwithstanding the appreciable increase in Capital Receipts in the 4th QTR 2021. The performance in Q1 is generally low due to dwindling FAAC allocation and non-receipt of aids and grants.

Total Capital receipts of \clubsuit 13,136,158,823.86 representing 8.5% of the budgeted figures is low for Q1. The problems bedevilling the gathering of information for Actual Aids & Grants has persisted despite improvement in the 4th quarter of 2021. The main drawback is that some MDAs are under reporting or out rightly fail to report on Actual Aids and Grants and other Capital Receipts. However, efforts are being made to increase information sharing across MDAs with a view to improve on report and returns on capital receipts in the 2nd QTR.

The First quarter actual total revenue of \(\pma 34,415,670,568.13\) (Thirty-Four billion, Four Hundred and Fifteen Million, Six Hundred and Seventy Thousand, Five Hundred and Sixty-Eight Naira, Thirteen Kobo) being 12.8% of the budget size was recorded for both Recurrent Revenue and Capital Receipts.

1.C Recurrent Expenditure Performance

The 1st quarter recurrent expenditures is in line with the current administration's policy of paying Salaries and Pensions as at when due, thus monthly payment of Salaries, Pensions and Gratuity arrears and regular

1.E Conclusions

The first quarter (Q1) 2022 Actual Recurrent Revenue and Actual Recurrent Expenditure Budget Performance are favourable. However, the need for more efforts to be made to improve the performance in respect of Capital Receipts (0.4%) and Capital Expenditure (8.2%) these performances are very poor. Thus the aggregate expenditure performance is low, which is largely due to nonrealization of capital receipts and low FAAC allocation. In conclusion, Borno State having commenced the implementation of the Public Financial Management (PFM) reforms with computerisation and automation of systems, efforts will be geared towards ensuring correct and timely electronic submission of returns by all MDAs to facilitate the production of more robust and comprehensive Budget reports in remaining quarters of the FY 2022.
