1 Summary of Performance

1.A Introduction

This Budget Performance Report for Borno State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes, the original approved budget and appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q2 report is assessed against the 2022 revised budget which includes a set of virements including a slight reduction in recurrent expenditure and an associate increase in capital expenditure.

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Finance, Budget and Economic Planning and published on the Borno State website.

1.B Revenue Performance

The total Recurrent Revenue performance in the 2nd Qtr., seems to be low (₦22,244,920,782.11) which is about 37.8% of the 2022 budgetary provision, this is regardless of gradual increase in crude oil prices. While growth in IGR was envisaged notwithstanding the generally slow economic activity occasioned by the insecurity in certain areas of the State. The IGR of about ₦3,443,938,676.19 representing 37.5% Of the budgeted figures. There is however room for improvement in Q3 as government is intensifying more efforts towards IGR.

Aids & Grants and Capital Receipts performance is low in 2nd quarter 2022, notwithstanding the appreciable increase in Capital Receipts in the 4th QTR 2021 and low performance in Q1. The performance in Q2 is generally low due to dwindling FAAC allocation and non-receipt of aids and grants.

Total Capital receipts of ₦13,895,736,840.84 representing 17.5% of the budgeted figures is also very low for Q2. The problems bedevilling the gathering of information for Actual Aids & Grants has persisted despite improvement in the 4th quarter of 2021. The main drawback is that some MDAs are under reporting or out rightly fail to report on Actual Aids and Grants and other Capital Receipts. However, more efforts are being made to increase information sharing across MDAs with a view to improve on report and returns on capital receipts in the 3rd QTR. The relatively poor performance of Grants and Loans is weighing on overall budget performance but hopefully, these items would catch up in the second half of the year.

The Second quarter actual total revenue of ₦36,140,657,622.95 (Thirty-Six billion, One Hundred and Forty Million, Six Hundred and Fifty-Seven Thousand, Six Hundred and Twenty-Two Naira, Ninety-Five Kobo) being 26.2% of the budget size was recorded for both Recurrent Revenue and Capital Receipts. Indeed, several IGR revenue items have already exceeded the 2022 budget because of the good revenue collection within the budget line items.

1.C Recurrent Expenditure Performance

The 2nd quarter recurrent expenditures is in line with the current administration's policy of paying Salaries and Pensions as at when due, thus monthly payment of Salaries, Pensions and Gratuity arrears and regular release of Overhead Costs to MDAs has continued, showing that the Actual recurrent expenditure recorded as at the end of Q2 for FY2022 was ₦9,919,867,211.97 (Nine Billion, Nine Hundred and Nineteen Million, Eight Hundred and Sixty-Seven Thousand, Two Hundred and Eleven Naira, Ninety-Seven Kobo) representing 23.1% of 2022 Budgeted figure. The recurrent expenditure comprises of Personnel cost of ₦5,697,068,700.51 representing 28.0%, Overhead cost of ₦3,942,395,582.49 representing 21.2% and other recurrent costs representing about 19.0%. However, the need for more efforts to be made to improve the performance in respect of social contribution in the 3rd QTR is in the pipeline.

1.D Capital Expenditure Performance

The Actual Capital Expenditure Performance for the Second Quarter (Q2) for FY2022 stood at ₦11,900,890,985.63 (Eleven billion, Nine Hundred Million, Eight Hundred and Ninety Thousand, Nine Hundred and Eighty-Five Naira, Sixty-Three kobo), representing 15.1% of the 2022 budgeted figures. The low performance may be as a result of low Capital inflows from budgeted sources and/or non-capture of some capital expenditure from some MDAs due to persistent late submissions of returns.

1.E Conclusions

The second quarter (Q2) 2022 Actual Recurrent Revenue and Actual Recurrent Expenditure Budget Performance are favourable. However, the need for more efforts to be made to improve the performance in respect of Capital Receipts (17.5%) and Capital Expenditure (15.1%) these performances are very poor. Thus, the aggregate expenditure performance is low, which is largely due to nonrealization of capital receipts and low FAAC allocation. In conclusion, Borno State having commenced the implementation of the Public Financial Management (PFM) reforms with computerisation and automation of systems, efforts will be geared towards ensuring correct and timely electronic submission of returns by all MDAs to facilitate the production of more robust and comprehensive Budget reports in remaining two (2) quarters of the FY 2022.
