



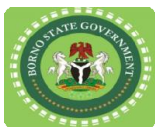

Pursuant to [Borno State Internal Revenue Service \(Re-Establishment, Harmonization and Administration\) Law, 2020](#), the Borno State Internal Revenue Service issues the following procedures for issuance of road worthiness Certificate in the State

ROAD WORTHINESS CERTIFICATE		
STEPS	PROCEDURE	TIME FRAME DURATION
1	<p>Vehicle owner presents for vehicle and vehicle documents for inspection at the Motor Vehicle Inspector's Office of the Borno State Internal Revenue Service along Kano road opposite Ramat Polytechnic.</p> <p>Required vehicle documents are:</p> <ol style="list-style-type: none">1. Number plate approval2. Vehicle licence3. Insurance certificate	Applicant's decision
2	<p>Vehicle Inspection Officer (VIO) assesses and inspects car and vehicle documents. RRR is generated provided the vehicle passes the inspection and the car particulars are up to date.</p>	1
3	<p>Vehicle owner proceeds to make payment into non-expendable TSA account through Remita amount. Payment depends on vehicle type and use: Private vehicles is ₦1,250 and ₦3,750 for commercial. Please see annexure for guidance on how to proceed with payment</p>	Applicant's decision
4	<p>Vehicle owner presents evidence of payment at the Motor Vehicle Inspector's Office of Borno State Internal Revenue Service along Kano road opposite Ramat Polytechnic.</p> <p>Certificate of road worthiness is stamped, signed and issued to the applicant by VIO.</p>	1

Guide to Remita Payment

This covers all forms of payment made in favor of Borno State Internal Revenue Service.

Follow the steps below to experience a swift payment process to Borno State Internal Revenue Service.

- Type <https://login.remita.net/remita/onepage/G0000303741/biller.spa> on your web browser
- On the field 'Who do you want to Pay' Type Revenue... A drop down with Borno State Internal Revenue Service will pop up. Click on it and supply the following information
 - Name of Service – CERTIFICATE OF ROAD WORTHINESS
 - Amount to pay
 - Payer's Name
 - Phone number
 - Payer's Email
 - Click on the check box 'I am not a robot' if asked
 - Click on SUBMIT button to proceed

You can now make payment via any of the payment channels convenient for you as follows:
